In the course of your dealings with the W Property Collection Sdn Bhd whether through our agents, independent contractors or staff/employees, you would have furnished to us your personal data such as NRIC / passport number, mobile contact numbers, residential address, email address(es) etc. This notice is to inform you the manner and purpose(s) by which and for which we will process your personal data and to seek your consent for us to process your personal data in accordance with the Malaysian Personal Data Protection Act 2010.

- b. furnish to, amongst others, our authorized agents, appointed consultants, appointed solicitors, so as to communicate with you on all matters incidental to your purchase of our property(ies);
- c. communicate with you on all matters incidental and related to the property(ies);
- d. inform you of promotions, sales and marketing of products and services offered by our associated/related/subsidiary companies.

- a. menyempurnakan transaksi jual beli dan bagi tujuan pentadbiran jual beli;
- b. bekalkan kepada, antara lainnya, ejen-ejen kami, penasihat-penasihat, peguam-peguam yang dilantik oleh kami, supaya mereka boleh berhubung dengan anda berkenaan perkara-perkara yang melibatkan pembelian hartanah kami;
- c. berhubung dengan anda berkenaan perkara-perkara yang melibatkan hartanah kami;
- d. menghubungi anda pasal promosi dan jualan produk dan perkhidmatan yang dibekal oleh mana-mana syarikat berkenaan dan anak syarikat kami.)

Your personal data will generally be kept confidential SUBJECT ALWAYS that you hereby consent and authorize us to furnish or disclose your personal data to the following categories of parties:-

- b. our related/associated/subsidiary companies, including those which may be established/incorporated in the future;
- c. our authorized agents, contractors, sub-contractors, suppliers, vendors, solicitors, consultants, auditors, accountants etc;
- d. government agencies, statutory authorities/bodies, industry regulators.
